- 1.2018 Apologies** Apologies were received from D Whitworth, R Pike and D Sellis
- 2.2018 Declarations of members interests** J Chalcraft and A Daniels declared an interest on the Bus Shelter.
- 3.2018 Minutes** The minutes of 14 November 2017 were agreed and signed.
- 4.2018 Matters arising** None.
- 5.2018 Council update reports from Devon County Council and West Devon Borough Council** B Lamb informed Councillors of a new waste contract that was being registered. West Devon Borough Council had a deficit of a quarter of a million. Training initiatives were being organized via Southern Link and the Monitoring Officer had sent details of a course on the Code of Conduct which Kathy Hoare was organizing. Pat Whympers was giving a talk on planning at Bere Ferrers on a Monday in February, the final date had yet to be arranged. Council went in to Part 2 and details of enforcement actions were given.

- 7.2018 DALC** Membership of DALC costs £118 for the current year, with a new cost due in March, as the end of the year was due it was agreed to leave joining until the next financial year.
