**Apologies** Apologies were received from J Hamilton, K Royston and D Whitworth.

**2017.1 Declaration of interests/Register of interests** J Chalcraft declared an interest on the Precept.

**2017.2 Minutes** The minutes of 8<sup>th</sup> November 2016 were agreed, all in favour.

**2017.3 Matters arising from the minutes**

- a. R Pike had attended the memorial service.
- b. K Royston and G Lister were to attend the planning training event at Lamerton.
- c. The drains at Gawton had been cleaned by Devon County Council.

**2017.4 Council update reports from Devon County Council and West Devon Borough Council** The joint local plan was ongoing. D Sellis congratulated the council on working with Devon County Council to get the drains cleared. An event had been arranged in Tavistock Town Hall on the 3<sup>rd</sup> February with a question time at 7.30pm and another meeting had been arranged for 25<sup>th</sup> February from 10am – 3pm concentrating on Mental Health, debt, social issues etc..

**2017.5 Correspondence**

- a. *Tavistock & District Local Transport Partnership* request for a donation. It was agreed to donate £25.00, all in favour.
- b. *BT* removal of telephone box at Mill Hill.

**2017.6 War memorial** progress Due to illness at Pascoes monumental masons the work on the war memorial had been delayed and was now due to be done in 2017.

**2017.7 Air Ambulance** landing location The proposed site had been looked at and was perfect except for the overhead cable which would cost £15000.00 plus VAT to remove, the total cost of the project was approximately £30,000 and was felt to be too much for a parish such as Gulworthy to provide.

**2017.8 Cemetery**

- a. General maintenance A quote had been received from P Badge for the general maintenance of Gulworthy Cemetery, it was agreed to place a further advert in the Tavistock Times for more quotations.

**2017.9 Planning**

- a. Applications received since 8<sup>th</sup> November 2016 None.

**2017.10 Computer/broadband facilities for the Clerk** There were problems with the clerks computer/broadband facilities and it was agreed to allocate £350 towards the total cost of £700 for a joint computer with Lamerton Parish Council.
